

**MINUTES — JULY 21, 2020**  
**CITY OF INDIAN ROCKS BEACH**  
**SPECIAL CITY COMMISSION MEETING**

The Indian Rocks Beach Regular City Commission Meeting was held on **TUESDAY, JULY 21, 2020**, in the City Commission Chambers, 1507 Bay Palm Boulevard, Indian Rocks Beach, Florida.

Mayor-Commissioner Kennedy called the meeting to order at 7:00 p.m., followed by the Pledge of Allegiance and ten seconds of silence.

**PRESENT:** Mayor-Commissioner Joanne Moston Kennedy, Vice Mayor-Commissioner Phillip J. Hanna, Commissioner Diane Flagg, Commissioner Edward G. Hoofnagle, Commissioner Joe McCall.

**1. RESOLUTION NO. 2020-08. Establishing the tentative millage rate for Fiscal Year 2020/2021.**

*[Staffing Report Begins]*

**BACKGROUND:** Pursuant to Florida Statutes, the City has received Form DR-420, Certificate of Taxable Value, from the Pinellas County Property Appraiser.

In order for the Property Appraiser to mail out TRIM notices, the City Commission is required to set a tentative millage rate.

The tentative millage rate is recommended to be 1.8326 mills. The Finance Director advises that the current rolled back rate would be 1.7323 based on the proposed valuation of \$1,334,284,367 for the City. With an adopted millage rate of 1.8326 for FY2020/21, an additional \$137,220.00 ad valorem tax revenue will be collected over current year collections.

**ANALYSIS:** Pursuant to Chapter 200.065(4)(d), F.S., once the tentative millage rate is set, in no event may the final millage rate that is adopted in September exceed the millage rate tentatively adopted; however, it may be lower.
