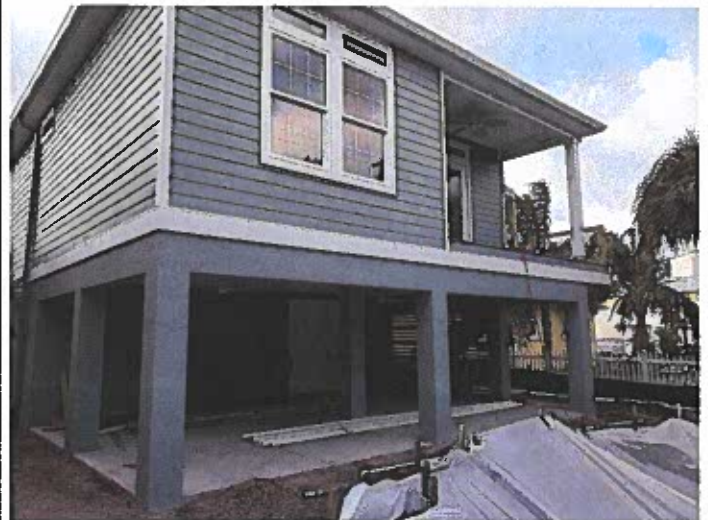

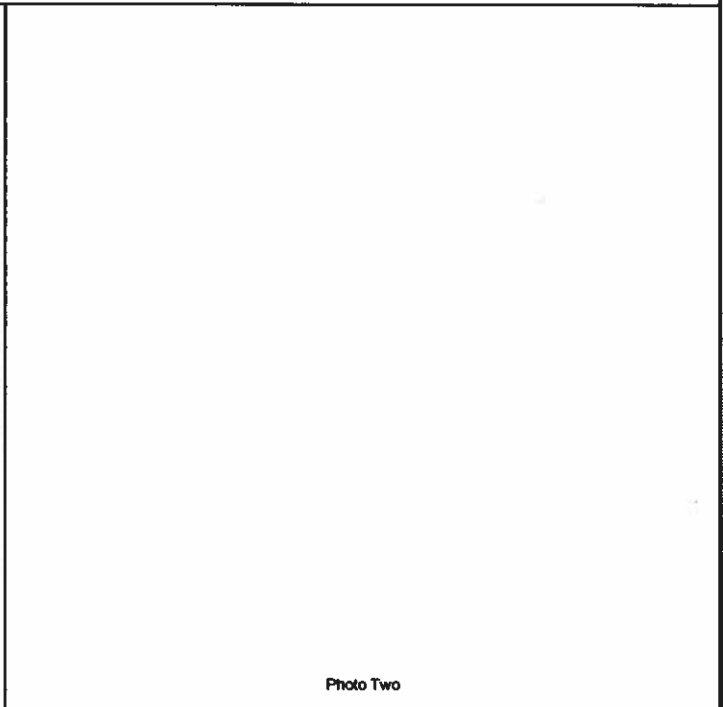

TYPICAL VENT

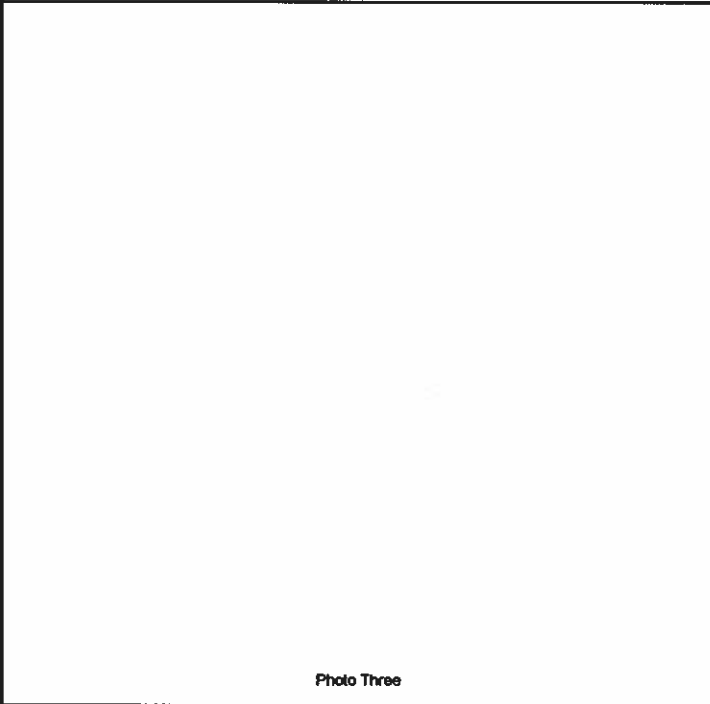

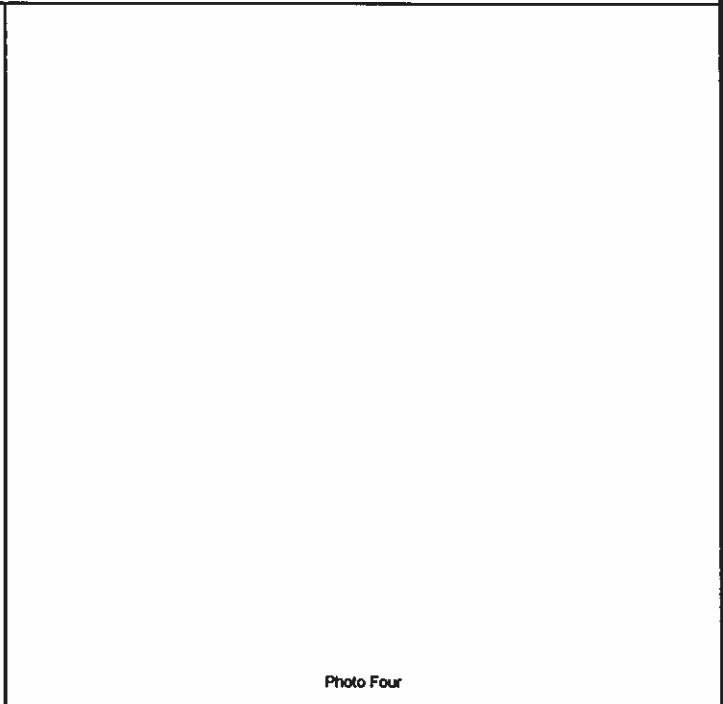
