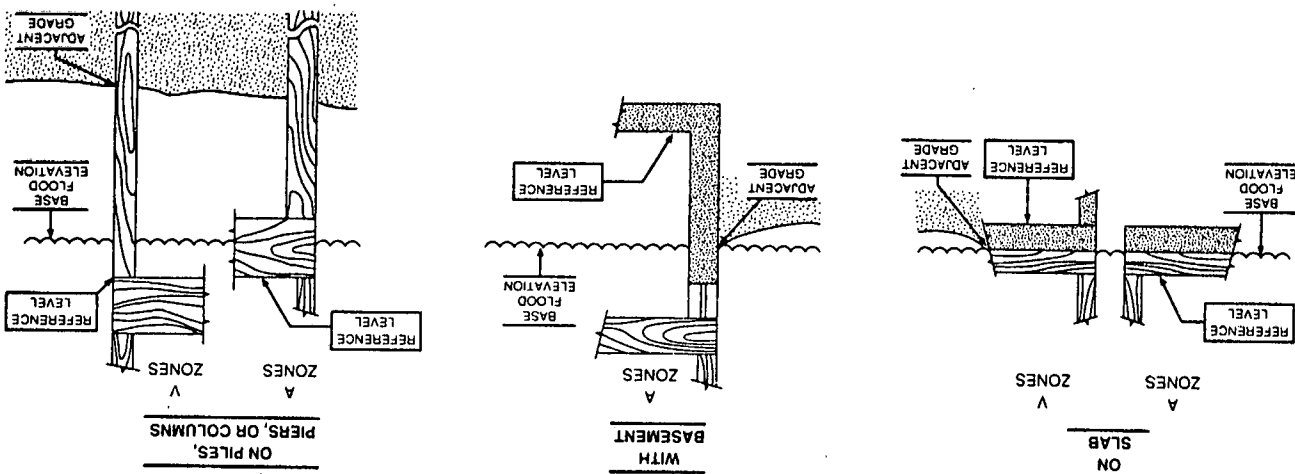
### SECTION C BUILDING ELEVATION INFORMATION
