SECTION E CERTIFICATION

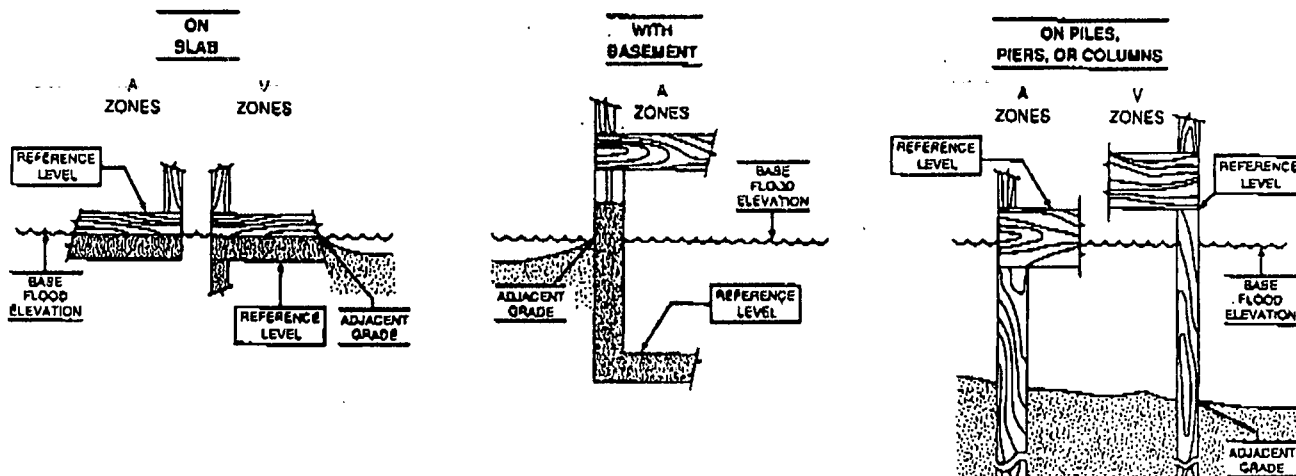
