


#### March 2024 Report


- There were 90 calls for Fire and Emergency Medical Services into Indian Rocks Beach in March: 76 EMS and 14 Medical. This was a record month of March, due to Spring Break. We did staff an additional unit, Rescue 27 for one week of Pinellas County Spring break, to handle the additional calls, while also keeping the fire suppression unit more available.
- The District is moving forward with the purchase of land on the northern end of Indian Rocks Beach, to better serve Indian Rocks Beach. This will greatly improve our response time and the current plans are to house an Advanced Life Support Fire Suppression Unit there with 3 firefighters/paramedics.
- We have obtained a transport capable rescue unit from the County to be utilized when staffing permits over the next year. A new Rescue Unit will be purchased and reimbursed by the County, with a written agreement forthcoming. We are also working with the County to obtain additional EMS funding to make this a permanent full-time unit. The Unit, Rescue 27 was staffed full time during spring break, and handled 24 medical emergencies throughout the District.
- The District is awarding a contract to build the Fire Station/Emergency Operations Center on the mainland, with an anticipated completion date of August 2025. This building will replace the 58-year-old fire station and serve as our Emergency Operations Center. Our design kick-off meeting is scheduled for April 5<sup>th</sup>.
- A jet ski with a rescue sled has been purchased by the District, funded by a very generous
  donation to the District. As you know, PSFRD has the busiest marine rescue program in the
  County, and the additional unit will assure that rapid access to victims in the water. The
  unit is being outfitted and training being provided to our members, with an anticipated inservice in May.
- Our Firefighters and Paramedics complete 902 hours of Fire and EMS Training in the Month of March.



Municipal General Election.

### **BACKGROUND:**

An election was held on March 19, 2024. Many municipal codes require that election results be ratified or declared by the governing body via resolution once the election results are certified by the canvassing authority. Alternately, codes may provide that election results are self-executing upon certification by the canvassing authority without resolution by the governing body. The City's Code is silent on the matter.

### **ANALYSIS:**

Although the City Attorney's Office is not aware of any statutory authority requiring ratification outside the context of a bond referendum, there is some old case law suggesting that it is necessary. Because the City's Code does not directly address the issue, the City Clerk has prepared this resolution in an abundance of caution.

The results of the Election are reported as follows:

# CITY OF INDIAN ROCKS RESOLUTION 2024-02

A RESOLUTION OF THE CITY COMMISSION OF INDIAN ROCKS BEACH, FLORIDA, ANNOUNCING THE RESULTS OF THE MARCH 19, 2024, GENERAL MUNICIPAL ELECTION, FOR THE MAYOR-COMMISSIONER SEAT AND TWO CITY COMMISSIONER SEATS, EACH TO BE SEATED FOR TWO-YEAR TERMS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Indian Rocks Beach Resolution No. 2023-07 called for a general election on March 19, 2024, for the purpose of electing, at large, qualified candidates to fill the vacancies of the Mayor-Commissioner Seat and two Commissioner Seats for two-year terms; and

WHEREAS, said Resolution No. 2023-07 stipulated in Section 2 that the outcome of the election for the Mayor-Commissioner Seat and the two Commissioner seats shall be determined by the candidates receiving the greatest number of votes for each seat; and

WHEREAS, at the close of the Candidate Qualifying Period at Noon on December 11, 2023, one qualified elector, namely Denise Houseberg had qualified to appear on the March 19, 2024 ballot as Mayor-Commissioner candidate and not others; and

WHEREAS, a Municipal Election was held on Tuesday, March 19, 2024 in the City of Indian Rocks Beach, Florida, to elect two persons to the City Commission, and

WHEREAS, the Pinellas County Canvassing Board served as the canvassing board for the City of Indian Rocks Beach for the purpose of declaring Election results as provided for in Section 3.1 of the City Charter and Article V, Section 22-131 of the Indian Rocks Beach Code of Ordinances, and

WHEREAS, the Pinellas County Canvassing Board did certify the election results on March 29, 2024, and has submitted the Certificate of the Pinellas County Canvassing Board with the Election results to the City, and

**WHEREAS,** the City of Indian Rocks Beach shall declare the results of this Election by means of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED:

## 1 C. PRESENTATION IRB Beach Community Food Pantry.

Presented by Robert Thacker.

### PUBLIC COMMENTS.

Mark Lusnia, 208 12<sup>th</sup> Avenue, stated he has a potential parking problem. People are parking on both sides of the street. He requested no parking signs on that side of the street.

Michael Campbell, 80 Gulf Boulevard, stated there are no EV charging stations, and would like to know why the three stations that the city did have were removed without consulting the public or Commission. He requested the Commission to send out a request for proposals from private companies to reinstall the charging stations.

Suzanne Gibson, 1206 Bay Shore Boulevard stated she is concerned with parking on both sides of the streets. When vehicles are parked on both sides it makes it impossible to move around and for emergency vehicles to get by, especially near the boat ramp. We should work on addressing the resident parking issues.

John Pfanstiehl, 448 Harbor Drive South, stated the Vacation Bill has passed. We need the Governor to Veto Senate Bill 280.

Beth McMullen, 481 Harbor Drive South, asked what happened to the two solar trash receptacle compactors that were given to the City by PSTA back in 2013. She stated that on April 1 the majority of Indian Rocks Beach waterways and the surrounding area will be in the seasonal

Florida Wildlife Commission Manatee Zone which slows the minimum wake restrictions. The restrictions are in place until October 31. This is in place to protect our manatees.

Diane Daniels, 309 10<sup>th</sup> Avenue, stated it is the 50<sup>th</sup> Anniversary of the Friends of the Library and they have a historical display. She stated on her walk to the meeting, she saw plastic bags in recycling containers. This is not allowed and wishes there were a way to message that better. Vacation Donations had a Food Drive on February 24 and will have another on March 30. She requested the city to look into a Community Refrigerator.

Mayor-Commissioner Kennedy closed the Public Comment.

# 3 A. REPORT OF the City Attorney.

City Attorney Mora stated the Legislative Session has closed and Senate Bill 280 regarding short-term rentals has passed. House Bill 267 and Senate Bill 684 on residential building permits did pass and changes the timelines on permit approvals.

City Attorney Mora stated that some exceptions have been made to a statue adopted last year requiring the city to adopt business impact statements when adopting a new ordinance and there are a series of changes to what is going to be required in the City comprehensive plans.

### BACKGROUND:

The applicant is requesting a variance from Sec.110-131(1) f.2 (i) of the Code of Ordinances of 3.34 ft into the 25 ft rear yard setback to allow for the constructed enclosure underneath the stairs in the rear yard. Section 110-245 (c) - **Structures extending over setback lines** allows open stairways to encroach into the rear yard setback not more than 10 ft, but not for enclosed stairways.

During the City's initial review, the owner asked if they could move the stairs into the rear yard setback and they were sent a copy of Section 110-245 (c) of the Land Development Code, governing the setback requirements for open stairways. The original plans the property owner submitted for City approval showed the stairs within the building envelope, without an encroachment into the rear setback.

During the Pinellas County Building department review process, the property owner submitted revised plans showing the stairs encroaching into the rear yard setback. Pinellas County, in its capacity as the City's building department, reviewed and approved the revised plans including the rear yard incursion of the enclosed stairwell. The City was not independently aware of this revision. The property owner constructed the building in conformity with the plans approved by the County, including the stairway's rear yard encroachment. After completing construction of the foundation and first floor of the structure, including the enclosed stairwell, the property owner submitted a tie-in survey to the Pinellas County Building department as part of the ordinary construction review process. A separate official within the County reviewed the tie-in survey and forwarded the plans to the City with specific attention to the stairs' encroachment. Given that the residential structure was well under construction and the stairs were enclosed underneath as an integral part of the structure, pursuant to reviewed and approved plans, the City's planning official approved the tie-in survey.

The property owner now seeks this variance to resolve the disparity between the City's code and the approved construction.

## Sec. 2-152. - Variances.

- (a) Generally; criteria for granting variances from the terms of subpart B.
  - (1) The board of adjustments and appeals shall make recommendations on and the city commission shall decide variance applications will not be contrary to the public interest, where, owing to special conditions, a literal enforcement of the provisions of subpart B will result in unnecessary and undue hardship. In order to recommend or decide any variance from the terms of subpart B, the board or the city commission shall consider each of the following.
  - a. Special conditions and circumstances exist which are peculiar to the land, structure or building involved and which are not applicable to other lands, structures or buildings in the same zoning district.

There are no special conditions that are peculiar to the land.

b. The special conditions and circumstances do not result from the actions of the applicant.

The applicant did not create any special conditions or circumstances.

c. Granting the variance will not confer on the applicant any special privilege that is denied by subpart B to other lands, structures or buildings in the same zoning district

Granting the variance would confer special privileges to the applicant.

d. Literal interpretation of the provisions of subpart B would deprive other properties in the same zoning district under the terms of subpart B and would work unnecessary and undue hardship upon the applicant.

The approval of this variance request would not deprive other owners of use and enjoyment of their properties.

e. The variance granted is the minimum variance that will make possible the reasonable use of the land, structure or building; and

This is the minimum variance to allow the stairs in the rear yard.

f. The granting of the variance will be in harmony with the general intent and purpose of subpart B, and such variance will not be injurious to the area involved or be otherwise detrimental to the public welfare.

Granting the variance will not be in harmony with the general intent and purpose of subpart B.

**NOTICE:** A public notice was mailed by first class mail to property owners within 150 feet in any direction of the subject property and posted on subject property on February 5, 2024 (Sec. 2-149 of the Code of Ordinances.)

Applicant James Savanella, 314 6<sup>th</sup> Avenue stated they have owned the property since 2008 and would like to retire in Indian Rocks Beach. He stated they did nothing to hurt their neighbors. He stated does believe they have done everything legally. It had been approved and inspected by the County.

Commissioner Houseberg asked if the was going to be a short-term rental.

The applicants replied in the negative.

City Attorney Mora stated that this is not a part of this case.

Vice-Mayor Commissioner Bond asked the applicant if they were aware of the potential pitfalls of the stairs in the back and what made you switch it to the side.

The Applicant replied It gains more room for the pool and deck.

Scott Moore with Mueller Remodeling Inc. 11090 66<sup>th</sup> Terrace N. Seminole, the applicant's contractor, stated they made the change to obtain more room for the deck area around the pool. The County approved the change and since then have had multiple inspections that have passed.

## **BACKGROUND:**

Alcoholic Beverage Use Designations are governed by Chapter 6, Alcoholic Beverages.

All alcoholic beverage licenses are under the control of the State of Florida, Division of Alcohol Beverages and Tobacco. However, municipalities have the right to enact ordinances regulating the hours of business and location of place of business and prescribing sanitary regulations thereof, of any license under the State Beverage Law within the county or corporate limits of such municipality. [F.S. 562.45(2)(a)]

On March 8, 2024, Peter Gottschling submitted a 2COP Alcoholic Beverage Designation Application (Beer & wine. By the drink or in sealed containers for consumption on or off premises where sold) for the establishment Grove Surf and Cafe, located at 1309 Gulf Boulevard, Indian Rocks Beach, Florida, legally described as Indian Beach Re-Revised, Block 30, Lot 23 and N ½ VAC Alley ADJ on S per O.R. 10763/1579.

Code Section 6-32 Alcoholic Beverage Use Designations are approved for a specific property location and a specific application. Any change in ownership of the establishment will require filing a new application and approval by the City Commission.

### ANALYSIS:

Grove Surf and Cafe is located at 1309 Gulf Boulevard in the B-Business District. The surrounding zoning is B-Business to the north and south, R2-Medium density multifamily zoning district to the east and CT-Commercial Tourist on the west side of Gulf Boulevard.

After a review of the application by the Planning Consultant, it was determined that the Alcoholic Beverage Application is in compliance with Chapter 6, Alcoholic Beverages, Chapter 110, Zoning, and parking is shared with the other tenants in this commercial plaza.

The Pinellas County Sheriff's Office reviewed its files for Peter Gottschling, and determined there are no responsive public records. No criminal record checks were conducted for the Florida Department of Law Enforcement, other states, or the FBI.

Section 6-33, Authority of City Commission to designate locations, empowers the City Commission to designate the location and classification and to place reasonable restrictions which are deemed appropriate such as repeated or intermittent nuisance activity and/or unlawful noise levels originating from the establishment of the parking area may result in the revocation of the alcoholic beverage designation.

**DISCUSSION** of appointing a Charter Review Committee.

### **BACKGROUND:**

#### Section 15.4. - Charter review committee.

- (a) The city commission shall appoint a charter review committee no sooner than five (5) years and no greater than ten (10) years beginning in January, 2014. The city commission, by resolution, shall establish membership, appointment and procedures of the Charter review committee.
- (b) The charter review committee will meet no later than thirty (30) days after appointment for the purpose of organization and shall elect a chair and vice chair from among its members. Further meetings of the charter review committee shall be held at the call of the chair. All meetings shall be open to the public. A majority of members shall constitute a quorum.
- (c) The charter review committee shall review the charter of the city and applicable county, state and federal statutes and laws in order to recommend amendments to the city Charter, if any. The charter review committee shall complete its review and submit its report to the city commission no later than six (6) months after the original appointment of the committee. Included in the report shall be any proposed amendments to the Charter. After review of the report by the city commission, the city commission may call for a referendum election on the proposed amendments, if any, in accordance with the general election laws of the State of Florida. Passage of amendments shall require approval of a majority of electors voting in said election on such amendment.

#### ANALYSIS:

As set forth in the City Charter, the City Commission must appoint a Charter Review Committee by January 2024.

Staff recommends that the City Commission discuss the establishment of the Charter Review Committee, and establish criteria for membership, appointment process and procedures or review process for inclusion in the development of a proposed ordinance for City Commission consideration.

Staff recommends that the City Commission take legislative action to establish the Charter Review Committee. Within this action, the City Commission must establish criteria for membership, set forth the process for the appointment of members and provide procedural or process for the Committee's utilization.

Per City Commission direction, staff will draft an ordinance for City Commission consideration incorporating the required criteria.
