BACKGROUND:

The City Commission previously established the proposed millage rate for Fiscal Year 2024/25 at 1.7300 mills, no change to the previous fiscal year millage rate.

ANALYSIS:

With a millage rate of 1.7300, the total estimated tax collection is \$3,549,380 based on a 97% collection rate. For Fiscal Year 2024/25, a mill rate of 1.7300 is 11.05% higher than the roll back rate of 1.5579. The proposed mill rate of 1.7300 remains one of the lowest in Pinellas County. Currently, mill rates in Pinellas County range from 0.5345 to 6.5000.

AN ORDINANCE OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR THE CITY OF INDIAN ROCKS BEACH, PINELLAS COUNTY, FLORIDA, FISCAL YEAR 2024/25; AND PROVIDING FOR NOTIFICATION OF REQUISITE GOVERNMENT AUTHORITIES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Indian Rocks Beach City Charter, Section 8.2. Ad Valorem Taxes, authorizes the City Commission to levy ad valorem taxes as necessary for the conduct of municipal government, and

WHEREAS, the City Commission of the City of Indian Rocks Beach, on July 16, 2024, adopted a Proposed Fiscal Year 2024/25 Millage Rate of 1.7300 following the first public hearing, as required by Florida Statute 200.065; and

WHEREAS, the City Commission of the City of Indian Rocks Beach, Florida, held a final public hearing on September 18, 2024 to adopt a Fiscal Year 2024/25 Final Millage Rate, as required by Florida Statutes 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within the City of Indian Rocks Beach, Pinellas County, Florida, has been certified by the Pinellas County Property Appraiser to the City Commission of the City of Indian Rocks Beach, Florida, as \$2,115,118,224.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, AS FOLLOWS:

Section 1. The Fiscal Year 2024/25 operating millage rate for Citywide expenses is 1.7300 mills which is more than the roll back rate of 1.5579 by 11.0500%.

Section 2. This Ordinance shall take effect immediately upon its adoption.

Section 3. The City is hereby directed to notify all pertinent governmental agencies of the provisions hereof, as required by law.

BACKGROUND

The City Commission reviewed the City Manager's proposed budget for Fiscal Year 2024/25 at a Budget Workshop on July 16, 2024. Prior to the budget work session, the City Manager and Finance Director met with each member of the City Commission to brief them on the proposed budget. In addition, the City of Indian Rocks Beach Finance and Budget Committee met on July 10, 2024, and unanimously endorsed the proposed budget.

The City Manager and Finance Director made presentations, which provided an overview of the Fiscal Year 2024/25 Program Budget, and together, the City Commission and staff reviewed all aspects of the proposed budget in detail. The budget includes a 5% pay raise for all team members. The Final Budget for Fiscal Year 2024/25 is the result of a consensus by the City Commission from the July Budget Workshop.

ANALYSIS

The final budget is balanced in all funds and presents a comprehensive plan for providing services during the coming fiscal year. With the approval of the Final Budget for Fiscal Year 2024/25, the City will establish a spending plan for Fiscal Year 2024/25 and provide approval for the City Manager to implement the plan. Attached to this agenda memorandum is the City Manager's July 1st, 2024, budget transmittal correspondence.

Amendment to Solid Waste Fee Schedule

BACKGROUND:

The City continues to maintain a high service level residential and commercial solid waste program that benefits its customers. Services include recycling, curbside pickup, and yard waste disposal. Section 50-91 (a) of the City's Code of Ordinances provides that the City Commission shall set all fees for the city's collection and disposal of garbage, trash, and other solid waste through the adoption of a resolution. The goal or emphasis of any solid waste rate increase is to adjust rates to allow for the solid waste fund to generate adequate income to satisfy annual cost requirements and provide minimal operating reserves of 3 months within the fund.

ANALYSIS:

A review of the solid waste fund revenue and expenditures was performed at the July 16, 2024, City Commission budget workshop. Based upon the most up-to-date data and economic factors, available adjustments were recommended to the current solid waste fees. Key areas include the generation of adequate annual operating income, significant increases in costs associated with curbside recycling, future capital equipment replacement costs, and the accumulation of operating reserves within the fund.

The Proposed Budget for FY 2024 reflects increases in monthly residential and commercial solid waste rates of 5.00%. The current \$36.78 per month charge for residential solid waste is recommended to increase to \$38.62.

MOTION:

Move to approve/deny Resolution No. 2024-09 to increase solid waste fees 5.00% for residential/multifamily and 5.00% for commercial solid waste customers for FY 2025.

CITY OF INDIAN ROCKS BEACH RESOLUTION NO. 2024-09

A RESOLUTION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, ENUMERATING THE DIFFERENT TYPES OF RESIDENTIAL AND COMMERCIAL SOLID WASTE COLLECTION METHODS AND AMENDING THE SCHEDULE OF FEES FOR THE COLLECTION, AND DISPOSAL OF GARBAGE, TRASH AND SOLID WASTE IN THE CITY OF INDIAN ROCKS BEACH, PURSUANT TO CHAPTER 50 – "SOLID WASTE", ARTICLE II – "COLLECTION AND DISPOSAL", DIVISION 3 – "FEES AND CHARGES", SECTION 50-91 – "FEE SCHEDULE", AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 50-91 of the City's Code of Ordinances provides that the City Council may establish all fees for the City's collection and disposal of garbage, trash and other solid waste; and

WHEREAS, the City Commission, with the input of City staff, has reviewed the existing schedule of the fees for solid waste collection and finds it necessary, appropriate, and in the interest of the public health and welfare to amend the previously-established fee schedule; and

WHEREAS, the Indian Rocks Beach City Commission desires to increase the solid waste fees for FY 2024/2025, effective October 1, 2024, owing to the increased costs of its contracts with vendors for the provision of solid waste services.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Indian Rocks Beach, Florida that:

Section 1. In accordance with Section 50-91 of the City's Code of Ordinances, the following fees are hereby established for the collection of solid waste:

- (a) Basic fees. The fees for pickup of garbage and trash are as follows:

 - (3) Commercial business establishment, five cans, two times per week, per month . . . \$33.47 \$35.14
 - (4) Dumpster rates:

 - b. Four yards, two times per week, per month.....\$472.04 \$495.64

- (b) Additional per-unit fee. In addition to the fees set forth in subsection (a) of this section, the amount of \$9.97 \$10.47 per unit per month shall be added to each of the basic fees for subsections (1) and (2), and the amount of \$11.31 \$11.88 per unit per month shall be added to the basic fees for subsections (3), (4), (5), and (6).
- (c) Compactor and front-end loader dumpsters. There shall be an administrative charge of \$304.51 \$319.74 per month for each compactor dumpster in excess of ten cubic yards. For compactor dumpsters and front-end loader dumpsters less than ten cubic yards, the administrative fee shall be \$152.27 \$159.88 per month per dumpster. Billing shall be on a bimonthly basis.
- (d) Commercial construction roll-off dumpsters. There shall be an administrative charge of \$250.00 for the use of commercial construction roll-off dumpsters. This charge shall be collected at the time of building permit issuance.

Section 2. Effective Date. This rate schedule shall take effect on October 1, 2024.

The City is adopting this resolution to address the fee schedule, contemplated in Section 50-91 (a) of the City's Code of Ordinances, governing the fees for solid waste collection.

- 2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City, if any:
- (a) An estimate of direct compliance costs that businesses may reasonably incur;

The solid waste collection fees for commercial solid waste customers, for Fiscal Year 2024/2025 will increase by 5% beginning on October 1, 2024.

(b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible; and

This resolution does not impose any new fees. It does, however, increase the solid waste collection fees for commercial solid waste customers, for Fiscal Year 2024/2025 will increase by 5% beginning on October 1, 2024.

(c) An estimate of the City's regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

The solid waste collection fees are being increased owing to significant increases in costs associated with curbside recycling, future capital equipment replacement costs, and the accumulation of operating reserves within the fund.

3. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance:

The rates are uniformly increasing by 5% for residential and solid waste and commercial solid waste collection, rendering this a resolution of general application. Accordingly, no particular industry or subset of properties is uniquely impacted or analyzed here.
