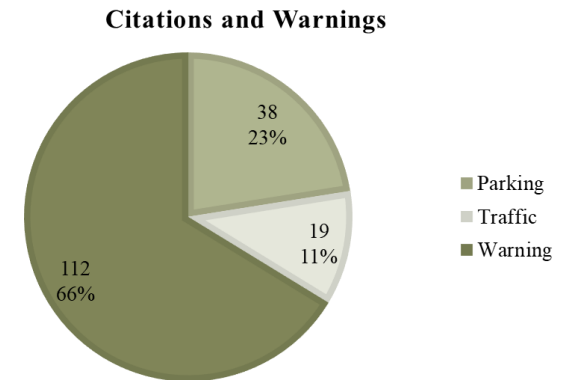

Mayor-Commissioner Houseberg called the meeting to order at 6:00 p.m., followed by the Pledge of Allegiance and a moment of silence.

MEMBERS PRESENT: Mayor-Commissioner Denise Houseberg, Vice-Mayor Commissioner Janet Wilson, Commissioner Jude Bond, and Commissioner John Bigelow, and Commissioner Hope Wyant.

OTHERS PRESENT: City Manager Gregg Mims, and City Clerk Lorin Kornijtschuk.

The former Commissioner, member of the Finance Committee, and community volunteer was presented with a plaque by City Manager Gregg Mims and Mayor-Commissioner Houseberg in recognition of her dedication to the City of Indian Rocks Beach.

1 A. REPORT OF Pinellas County Sheriff's Office.

A PCSO representative stated the month's report was not ready due to the Labor Day Holiday. Commissioner Bond requested data for comparison of this year's activity with the previous years.

1 B. REPORT OF Pinellas Suncoast Fire & Rescue District.

Pinellas Suncoast Fire & Rescue District Fire Chief Jeffrey Davidson reviewed the fire district's monthly report. He stated the third annual September 11 Memorial Walk would take place on September 11 at 8 a.m.

A request was made for a comparative report of emergency calls over the past four years.

The City Manager provided his written report.

The City Manager stated that activities are increasing, particularly in the area of vacation rental compliance. Efforts to manage vacation rental registrations are progressing well. He stated that a shade meeting is requested by the City Attorney to discuss seven pending short-term rental lawsuits.

Commissioner Bond had nothing to report.

Commissioner Wyant had nothing to report.

Vice-Mayor Commissioner Wilson stated that she attended the Florida League of Cities conference in August, which proved to be a valuable learning experience. As a result, she was accepted to one of the Florida legislative policy committees focused on development code compliance and redevelopment. She mentioned that she had previously worked on similar legislative issues in Ohio, so she feels comfortable in this area. Meetings are scheduled for October, November, and December, where discussions will focus on ways to enhance the home rule situation. She looks forward to reporting back each month on the progress of these committees.

1 A. ORDINANCE NO. 2024-01 — PUBLIC HEARING / FIRST READING.

Adopting the final levying of ad valorem taxes for the City of Indian Rocks Beach, Pinellas County, Florida, Fiscal Year 2024/2025; providing for notification of requisite government authorities; and providing for an effective date.

[Beginning of Staff Report]

BACKGROUND:

The City Commission previously established the proposed millage rate for Fiscal Year 2024/25 at 1.7300 mills, with no change to the previous fiscal year millage rate.

ANALYSIS:

With a millage rate of 1.7300, the total estimated tax collection is \$3,549,380 based on a 97% collection rate. For Fiscal Year 2024/25, a mill rate of 1.7300 is 11.05% higher than the rollback rate of 1.5579. The proposed mill rate of 1.7300 remains one of the lowest in Pinellas County. Currently, mill rates in Pinellas County range from 0.5345 to 6.5000.

BACKGROUND:

The City Commission reviewed the City Manager’s proposed budget for Fiscal Year 2024/25 at a Budget Workshop on July 16, 2024. Prior to the budget work session, the City Manager and Finance Director met with each member of the City Commission to brief them on the proposed budget. In addition, the City of Indian Rocks Beach Finance and Budget Committee met on July 10, 2024, and unanimously endorsed the proposed budget.

The City Manager and Finance Director made presentations, which provided an overview of the Fiscal Year 2024/25 Program Budget, and together, the City Commission and staff reviewed all aspects of the proposed budget in detail. The budget includes a 5% pay raise for all team members. The Final Budget for Fiscal Year 2024/25 is the result of a consensus by the City Commission from the July Budget Workshop.

ANALYSIS:

The City continues to maintain a high service level residential and commercial solid waste program that benefits its customers. Services include recycling, curbside pick-up, and yard waste disposal. The fee schedule for the collection and disposal of solid waste of the City is set forth in the City Code, Section 50-91. The goal or emphasis of any solid waste rate increase is to adjust rates to allow for the solid waste fund to generate adequate income to satisfy annual cost requirements and provide for minimal operating reserves of 3 months within the fund.

ANALYSIS:

A review of the solid waste fund revenue and expenditures was performed at the July 16th, 2024, City Commission budget workshop. Based upon the most up to date data and economic factors available adjustments were recommended to the current solid waste fees. Key areas include the generation of adequate annual operating income, significant increases in costs associated with curbside recycling, future capital equipment replacement costs, and the accumulation of operating reserves within the fund.

The Proposed Budget for FY 2024 reflects increases in monthly residential and commercial solid waste rates of 5.00%. The current \$36.78 per month charge for residential solid waste is recommended to increase to \$38.62.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, MAKING FINDINGS; APPROVING AND RATIFYING ALL EMERGENCY DECLARATIONS AND EXTENSIONS THEREOF; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as of September 23, 2024, showers and thunderstorms located over the northwestern Caribbean Sea and portions of Central America were associated with a broad area of low pressure, then identified as Potential Tropical Cyclone Nine and eventually as Hurricane was forecast to bring severe weather impacts to parts of Florida, including the City; and

WHEREAS, on September 23, 2024, the Governor of the State of Florida issued Executive Order 24-208 declaring a State of Emergency in multiple Florida counties, including all of Pinellas County, as a result of Hurricane Helene; and

WHEREAS, on September 24, 2024, the Governor of the State of Florida promulgated Executive Order 24-209, amending Executive Order 24-208; and

WHEREAS, the Governor's Emergency Declarations included all of Pinellas County, including the City; and

WHEREAS, on September 24, 2024, the Pinellas County Board of County Commissioners declared a State of Local Emergency for Hurricane Helene; and

WHEREAS, on September 26, 2024, at 11:10 p.m. EDT, Hurricane Helene made landfall at an estimated 10 miles west-southwest of Perry, Florida, as a Category 4 storm, with winds reaching 140 mph; and

WHEREAS, as a direct result of Hurricane Helene coastal portions of Pinellas County, including the City of Indian Rocks Beach, saw record storm surge with extensive flooding that caused widespread damage and some fatalities within the City; and

WHEREAS, after Hurricane Helene, on or about October 2, 2024, the City noticed a public meeting of the City Commission to occur on Tuesday, October 8, 2024; and

WHEREAS, on October 3, 2024, the Governor issued Executive Orders 24-212 and 213, to address additional legal, administrative, and logistical issues caused by Hurricane Helene; and

WHEREAS, on October 5, 2024, Governor Ron DeSantis issued Executive Order 24-214 which declared a State of Emergency for multiple counties, including Pinellas County, due to the anticipated landfall of Hurricane Milton, which threatened Pinellas County with a major disaster; and

WHEREAS, following the Governor’s declaration of a State of Emergency owing to the anticipated landfall of Hurricane Milton, the City cancelled the City Commission meeting noticed to occur on October 8, 2024; and

WHEREAS, on October 7, 2024, the Pinellas County Board of County Commissioners, issued an Emergency Order extending the state of local emergency for Hurricane Helene and adding Hurricane Milton to the state of local emergency via Resolution; and

WHEREAS, on October 9, 2024, the Mayor of the City of Indian Rocks Beach declared a state of emergency owing to the impact of Hurricane Helene, and the anticipated impact of Hurricane Milton (together with Hurricane Milton, the “Hurricanes”); and

WHEREAS, at approximately 8:30 p.m., on October 9, 2024, Hurricane Milton made landfall as a Category 3 hurricane with winds approximating 120 mph, at or near Siesta Key, Florida, approximately 50 miles south by southeast of Indian Rocks Beach; and

WHEREAS, the Mayor has the authority to and has extended the State of Emergency declared as a result of the Hurricanes; and

WHEREAS, Florida Statutes Chapter 252 provides authority for a political sub-division such as the City of Indian Rocks Beach to declare a State of Emergency allowing the City to waive the procedures and formalities otherwise required of political subdivisions pertaining to:

1. Performance of public work and taking whatever action is necessary to ensure the health, safety and welfare of the community.
2. Entering into contracts;
3. Incurring obligations;
4. Employment of permanent and temporary workers;
5. Utilization of volunteer workers;
6. Rental of equipment;
7. Acquisition and distribution, with or without compensation of supplies, materials and facilities;
8. Appropriation and expenditures of public funds.

WHEREAS, the City Commission finds that, as of the dates of the Governor’s Executive Orders, Pinellas County’s Emergency Resolutions, and the Mayor’s finding of a state of emergency and extensions thereof, there has been and presently remains a state of emergency throughout the City as a direct result of Hurricanes Helene and Milton.

WHEREAS, the City Commission has been unable to convene until the public meeting held on October 29, 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, THAT:

SECTION 1. Recitals. Each of the above recitals are incorporated herein as the findings of the City Commission.

SECTION 2. Emergency Proclamation.

- A. Emergency Confirmed.** The City Commission hereby confirms and ratifies Proclamation 2024-01 declaring a state of local emergency within the corporate boundaries of the City of Indian Rocks Beach as a direct result of the impacts of Hurricane Helene and Hurricane Milton, and all presently-existing proclamations extending the local emergency.
- B. Emergency Extended.** The City Commission formally finds that the emergencies declared by the Governor, County Commission, and Mayor in the City owing to the Hurricanes remain. The City Commission reserves the authority to formally extend or otherwise approve any further extension of the State of Local Emergency by the Mayor resulting from Hurricane Helene and Hurricane Milton
- C. Emergency Powers Preserved.** The city manager or his designee, in the absence of the city manager, shall continue to act as the director of emergency powers, and possess all powers, duties, and responsibilities granted by the City's Code of Ordinances, Florida, and federal law. Such authority shall continue until rescinded by the City Commission.

SECTION 3. Severability. If any section, subsection, sentence, clause, provision, or word of this Resolution is held unconstitutional or otherwise legally invalid, same shall be severable and the remainder of this Resolution shall not be affected by such invalidity, such that any remainder of the Resolution shall withstand any severed provision, as if the City Commission adopted the Resolution absent any invalidated portion.

SECTION 4. Effective Date. This Resolution shall become effective immediately upon its adoption.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, SETTING FORTH CERTAIN EMERGENCY RESPONSE POLICIES RELATED TO HURRICANE HELENE; MAKING RELATED FINDINGS; ESTABLISHING CONDITIONS PERMITTING TEMPORARY RESIDENTIAL HOUSING; PROVIDING FOR PUBLICATION, PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as of September 23, 2024, showers and thunderstorms located over the northwestern Caribbean Sea and portions of Central America were associated with a broad area of low pressure, then identified as Potential Tropical Cyclone Nine and eventually as Hurricane Helene (including all progressive designations of the storm system, the “Hurricane”) was forecast to bring severe weather impacts to parts of Florida, including the City; and

WHEREAS, on September 23, 2024, the Governor of the State of Florida issued Executive Order 24-208 declaring a State of Emergency in multiple Florida counties, including all of Pinellas County, as a result of the Hurricane; and

WHEREAS, on September 24, 2024, the Governor of the State of Florida promulgated Executive Order 24-209, amending Executive Order 24-208; and

WHEREAS, the Governor’s Emergency Declarations included all of Pinellas County, including the City; and

WHEREAS, on September 24, 2024, the Pinellas County Board of County Commissioners declared a State of Local Emergency for the Hurricane; and

WHEREAS, on September 26, 2024, at 11:10 p.m. EDT, Hurricane Helene made landfall at an estimated 10 miles west-southwest of Perry, Florida, as a Category 4 storm, with winds reaching 140 mph; and

WHEREAS, coastal portions of Pinellas County, including the City of Indian Rocks Beach, saw record storm surge with extensive flooding; and

WHEREAS, several residential structures in the City have been damaged or destroyed, and rendered temporarily or permanently uninhabitable; and

WHEREAS, Florida Statutes Chapter 252 provides authority for a political sub-division such as the City of Indian Rocks Beach to declare a State of Emergency allowing the City to waive the procedures and formalities otherwise required of political subdivisions by law pertaining to:

1. Performance of public work and taking whatever action is necessary to ensure the health, safety and welfare of the community.
2. Entering into contracts;
3. Incurring obligations;
4. Employment of permanent and temporary workers;
5. Utilization of volunteer workers;
6. Rental of equipment;
7. Acquisition and distribution, with or without compensation of supplies, materials and facilities;
8. Appropriation and expenditures of public funds.

WHEREAS, in the aftermath of Hurricane Helene and the resulting displacement of residents from their homes, the City has received requests for the placement of temporary living quarters on the properties of homeowners until homeowners are able to repair or rebuild their homes; and

WHEREAS, Section 62-36 of the City's Code of Ordinances prohibits any house trailer, house car, or similar structure from being used for living, sleeping, or business purposes anywhere within the City, unless in a duly licensed and regulated trailer park or trailer camp, or where, subject to additional limitations, it is used for tools, equipment, or materials being used in connection with the construction of a permanent building; and

WHEREAS, Section 90-80 of the City's Code of Ordinances prohibits the permanent placement of recreational vehicles and park trailers in flood hazard areas; and

WHEREAS, despite the foregoing provisions, Florida Statutes § 166.0335 provides that, notwithstanding any other law, ordinance, or regulation to the contrary, following the declaration of a state of emergency issued by the Governor for a natural emergency during which a permanent residential structure was damaged and rendered uninhabitable, a municipality may not prohibit the placement of one temporary shelter on the residential property for up to 36 months after the date of the declaration or until a certificate of occupancy is issued on the permanent residential structure on the property, whichever occurs first, if all of the following circumstances apply:

- (a) The resident makes a good faith effort to rebuild or renovate the damaged permanent residential structure, including, but not limited to, applying for a building permit, submitting a plan or design to the municipality, or obtaining a construction loan.
- (b) The temporary shelter is connected to water and electric utilities and does not present a threat to health and human safety.
- (c) The resident lives in the temporary structure; and

WHEREAS, it has been necessary for the City of Indian Rocks Beach to take protective and responsive measures to ensure the health, safety, and welfare of its residents and property; and

WHEREAS, Section 2-332 of the City's Code of Ordinances provides that the City is not required to seek bids or multiple quotes for contracts during the first 30 days of an emergency,

which is defined to include “a weather event such as flood, hurricane, or tornado,” and a “disruption in the city’s utility system”; and

WHEREAS, Section 2-332 of the City Code of Ordinances provides that the City is not required to seek bids or multiple quotes for purchases regarding the emergency repair of the city’s facilities or equipment; and

WHEREAS, the City Commission finds that, as of the dates of the Governor’s Executive Orders and that of the Pinellas County Board of Commissioners, there has been and presently remains a state of emergency within the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF INDIAN ROCKS BEACH, FLORIDA, that:

SECTION 1. Recitals. Each of the above recitals are incorporated herein as the findings of the City Commission.

SECTION 2. Emergency Protocols.

1. The City Commission hereby acknowledges, confirms, endorses, and ratifies the Governor and County Commission’s declaration of a state of emergency within an area fully encompassing the corporate boundaries of the City of Indian Rocks Beach as a direct result of the anticipated and realized impacts of Hurricane Helene, and formally finds that the City presently remains in a state of local emergency.
2. The City Commission hereby ratifies the waiver of any procedures and formalities as provided in Florida Statutes Chapter 252, including any measure taken by the City Manager or other City officials to respond to the emergency prior to the adoption of this Resolution, including, but not limited to the acquisition of emergency debris removal services and the emergency repair of the City’s facilities and equipment.

SECTION 3. Procurement. As a result of the declared state of emergency, the City Manager shall continue to have the authority to waive competitive procurement requirements, as set forth in Section 2-332 of the City’s Code of Ordinances (unless otherwise prohibited by state law or federal grant requirements) when acquiring any services or commodities related to the City’s response to the emergency conditions, including but not limited to any and all cleanup, repair and re-construction efforts related to City property, rights-of-way, or infrastructure.

SECTION 4. Temporary Housing Following Declared Emergency. Notwithstanding the provisions of Section 62-36 and 90-80 of the City's Code of Ordinances, the City's code enforcement officers and inspectors shall not enforce those provisions to the extent those provisions conflict with Florida Statutes § 166.0335. Therefore, all residents are permitted to place a recreational vehicle or trailer on their residential property in the following circumstances:

1. The resident's permanent residential structure was damaged and rendered uninhabitable by the Hurricane Helene flooding; and
2. The resident is making a good faith effort to rebuild or renovate the damaged permanent residential structure, including, but not limited to, applying for a building permit, submitting a plan or design to the municipality, or obtaining a construction loan; and
3. The recreational vehicle or trailer is properly connected to water, sewer, and electric utilities and does not present a threat to health and human safety (as determined by the Pinellas County Health Department, Fire Marshal, a Sheriff's Deputy, the City's Building Official, or a City code enforcement officer or inspector), and
4. The resident lives in the temporary structure, and
5. The recreational vehicle or trailer is placed on the property no longer than 36 months after September 23, 2024, or until a certificate of occupancy is issued on the permanent residential structure on the property, whichever occurs first.

SECTION 5. Publication. The City Manager, or any person he so designates, shall ensure a copy of this Resolution is provided to the City's Building Official and the City's code enforcement personnel.

SECTION 6. Severability. If any section, subsection, sentence, clause, provision, or word of this Resolution is held unconstitutional or otherwise legally invalid, same shall be severable and the remainder of this Resolution shall not be affected by such invalidity, such that any remainder of the Resolution shall withstand any severed provision, as the City Commission would have adopted the Resolution even absent the invalid part

SECTION 7. Conflict. Any prior motion or Resolution adopted by the City Commission which conflicts with this Resolution is hereby repealed.

SECTION 8. Effective Date. This Resolution shall become effective immediately upon its adoption.

RE: IRB Charter Review Committee – Findings & Recommendations

Article XV of the City of Indian Rocks Beach’s (the “City”) Charter provides that the City Commission, by resolution, shall establish membership, appointment, and procedures for the City’s Charter Review Committee (the “Committee”). On April 9, 2024, the City Commission adopted Resolution No. 2024-05, establishing and appointing officials to the Committee.

Between June and September 2024, the Committee has met to review the City’s Charter and determine what changes, if any, the Committee deems appropriate and necessary. Based on the diligent review of the individual members, administrative input, legal advice, and the Committee’s deliberation, the Committee recommends the following revisions.

I. COMMISSIONER TERMS OF OFFICE: INCREASED TO THREE (3) YEARS

A. GENERALLY

The Committee recommends the City Commission consider advancing a proposed charter amendment for the City’s electors’ consideration, increasing the term of office for individual commissioners from two (2) years to three (3) years. The Committee’s position was that two years did not provide sufficient time for the City’s elected officials to learn and effectively serve in their positions. Additionally, the two-year term limits the elected officials’ ability to be involved in intergovernmental and community organizations in tandem with their elected service.

B. CHARTER § 2.2 (C) – CITY COMMISSION CREATED; QUALIFICATIONS; TERMS OF OFFICE; AND VACANCIES.

(c) *Term of office.* Term of office of a commissioner shall be for a period of ~~two (2)~~ three (3) years from the first meeting following certification of election to such office, beginning in the year ~~1992~~ 2026. Challenge and recount will be conducted in accordance with provisions of Florida Statutes.

C. CHARTER § 3.1 (B) – MANNER OF HOLDING ELECTIONS.

(b) Elections for the mayor-commissioner shall be held every other year in March; elections for two (2) commissioners shall be held each year in March. All terms of office shall be for ~~two (2)~~ three (3) years.

II. ELECTIONS: MOVE FROM MARCH TO NOVEMBER

A. GENERALLY

The Committee recommends the City Commission consider advancing a proposed charter amendment for the City's electors' consideration, changing the City's election cycles from March of each year to November. The Committee believes that moving the election to November has the potential to save the City money by aligning the election with the ordinary cycle for other statewide and national elections. Moving the election to the November election cycle may also increase voter turnout in local elections.

Notably, if this provision were to be adopted the City would have to adopt an ordinance amending Section 22-34 of the City's Code of Ordinances governing the qualifying period, as the present language establishes a qualifying period in December, for a March election.

B. RELEVANT CHARTER PROVISIONS

1. Charter § 3.1 (a) – (b)

(a) Municipal elections in the City of Indian Rocks Beach shall be held ~~on the second Tuesday in March~~ in November of each year, in alignment with any corresponding county, state, or national elections beginning in ~~1984~~ 2026 for the purpose of electing successors to each elective office.

(b) Elections for the mayor-commissioner shall be held every other year in ~~March~~ November; elections for two (2) commissioners shall be held each year in ~~March~~ November. All terms of office shall be for two (2) years.

C. RELEVANT CODE PROVISIONS

1. Code of Ordinances § 22-34 – Time for Qualifying

For a regular election, no person may qualify as a candidate prior to noon of the first Monday in **December**, but no later than noon of the second Monday in **December**, preceding the next regular city election.

III. APPEALS: CONSISTENCY

A. GENERALLY

The Committee recommends the City Commission consider advancing a proposed charter amendment for the City's electors' consideration concerning the consistency of references to appellate proceedings. Rather than propose specific language, the Committee recommended that the Commission consider whether to direct the City Attorney to propose language that is legally sufficient with consideration to due process and other similar procedural considerations.

Upon review, the City Attorney recommends removing both referenced appeal provisions in the City Charter as they are inconsistent with state law and other applicable legal principles. Notably, there are numerous provisions within the City's Code of Ordinances alternatively providing for appeals in a manner more consistent with the applicable law.

B. RELEVANT CHARTER PROVISIONS

1. Charter § 13.3 (c) – Comprehensive Plan Appeals to the city commission.

An appeal to the city commission may be taken by any person aggrieved by the decision of any administrative officer designated or appointed to carry out the rules and regulations prescribed by the city commission. However, such appeals shall be taken within thirty (30) days from the date of the decision of filing with the commission a notice of appeals specifying the grounds thereof. The officers from whose decision the appeal is taken shall forthwith transmit to the city commission copies of all papers constituting the record upon which the action of appeal was taken. The city commission shall fix a time and place for the hearing of appeal giving public notice thereof as well as due notice to the party of interest and decide the same within ninety (90) days. At the time of hearing, any party may appear in person or by attorney.

2. Charter § 13.4 (d) - Any person or persons, jointly or severally aggrieved by any act of the city commission under the powers herein granted to said city commission, may present to the appropriate court of law a petition duly verified, setting forth that such act is illegal in full or in part, particularly specifying the grounds of illegality. Such petition shall be presented to said court within thirty (30) days after the act or acts of the city commission upon which the petition is based; or no action, suit or other proceeding in any manner questioning the legality of said act or acts shall lie for any cause whatsoever. Appeal to the city commission is a precondition to suit and a mandatory administrative remedy.

3. CODE § 2-280: APPEALS (CODE ENFORCEMENT)
4. CODE § 2-295: APPEAL (FORECLOSURE/MAINTENANCE PROCEDURES)
