# PRE-APPROVAL FOR IMPROVEMENTS THAT DO NOT EXCEED 50% OF STRUCTURE VALUE FOR RESIDENTS THAT HAVE NOT RECEIVED SD/NSD LETTER OR RESIDENTS THAT HAVE RECEIVED A NSD LETTER

Applicants can choose not to wait for the SD/NSD Estimator modeling/determination letter and proceed with a detailed SD review and determination. Subject to the determination, a permit may be able to proceed under Substantial Improvements processes if the home was determined to NOT be substantially damaged.

If the structure is non substantially damaged you can apply for a building permit.

To apply for a permit for the restoration work you first need pre-approval from the City. To apply for pre-approval return all of the completed documents to: <a href="https://hurricanerestorationpreapproval@irbcity.com">hurricanerestorationpreapproval@irbcity.com</a>.

If you are using the value from the Property appraiser's website:

#### You will need the following documents:

- 2. Date Stamped photos with verified flood damage level (measuring tape) and before photos of the interior space. (Do not need to be date stamped)
- 3. Plan with dimensions and scope of work. See example <u>here</u>.

- a. Application for Construction in a Floodplain
- b. Floodplain Cost Breakdown package
- c. Floodplain Substantial Improvement Disclosure form
- 4a. Property Appraiser's FEMA letter of value

  - In the Quick Search area, enter the address and click the search button.
  - After the page loads, you should see "Quick Pick Tool" on the right. Click on "FEMA/WLM Letter"


